19 –30 May, Suva, Fiji The Border Control Training was officially opened by the French Ambassador HE Jean-Pierre Vidon, at the Secretariat Forum Malolo Bure. 15 course participants from Immigration and Customs

Administrations around the Pacific Region attended the course; most of them had attended the course that was held in 2002.

This years training was organised by the new Forum Law Enforcement Training Coordinator, Mark Whitfield. Out of the 15 participants who attended, 10 were from Immigration Administrations in New Caledonia, Fiji, PNG, Tuvalu, Solomon Islands, Samoa and Vanuatu.

The Fiji National Training Council directed the first week of the course. Training was conducted by Mere Tuisawau. She took the course participants through the 'Training of Trainers Module I -Instructional Skills' Workshop. This will help the participants with skills on how to conduct border control training or workshops in their respective workplaces in their home countries.

The second week of the course was run by Philip Dale, a DIMIA representative from the Australian High Commission, Mike Lynch the Melanesian Counter-Terrorism Project Officer and Mark Whitfield the Forum's Law Enforcement Training Coordinator. They took the course participants on subjects related to border control and transnational crime, including practical components where participants prepared programs for delivery at national levels. They also covered subjects such as identifying fraudulent passports, tickets and associated documents.

The course participants had a chance to tour the Suva wharf and see the work carried out by Fiji Customs and Immigration officers when clearing foreign vessels that arrive in Fiji. At the end of the course the participants were given Certificates of Attainment from the Fiji National Training Council for completing the 'Training the Trainers Module I and passing the prescribed requirements.

15 NEW TRAINING INSTRUCTORS FOR THE PACIFIC REGION

There are now 15 new qualified Training Instructors in the Pacific Region following the conduct of the Border Control Training Program 2003 at the Forum Secretariat in May 2003.

Course participants completed one week of the Fiji National Training Council "Train the Trainer" program. This concluded with a written examination, a comprehensive training project and the delivery of lessons to the group. This is an accredited course and participants can now officially call themselves Training Instructors.

The second week of the program involved a series of presentations from Department of Immigration and Multicultural Affairs (DIMIA Australia) and training development activities. This phase was aimed at developing document examination skills and then practicing the skills needed to teach them back in the work place.

Frontline document examination equipment was issued to the participants and will also be sent to other regional partners.

The program was funded through the French Government and the Australian Federal Police Law Enforcement Cooperation Program. The Forum Secretariat coordinated and administered the program.

The challenge for organisations, who attended this program and others like it, is to now get those participants out into the work place to pass on these valuable skills. Such activities require strong management support and leadership. The benefits will be an increase in the skill level of employees which can lead to a greater success rate in detecting fraudulent documents at the borders which will help to make life tough for criminals in the Pacific region.

REPORT FROM THE PIDC SECRETARIAT

Bula from the PIDC Secretariat!

The PIDC Secretariat has been quite busy during the last two months with a number of tasks undertaken. We have developed the "Attempted Clandestine Arrival Report" and the "Fraudulent Visa and Passport Report", which have been forwarded to all member countries and we hope that all members will use these forms.

The Secretariat will be using these reports to develop a database and to analyse data received for the use of all PIDC Members. Also being developed by the Secretariat is the Immigration Contingency Plan for Mass Arrivals.

PIDC was represented by the Secretariat at the Pre-FRSC meeting in Nadi, from 1-2 May, where by a number of regional law enforcement papers for the FRSC Meeting were drafted. At the FRSC meeting in Nadi from 18-20 June, the Secretariat tabled our PIDC report and the report on "People Smuggling, Trafficking and Illegal Migration in the Pacific: A Regional Perspective".

The second Expert Working Group Meeting was held from 5-6 May at the Forum Secretariat. The group is coordinating the development of a regional framework including the Model Legislation to address Terrorism& Transnational Organised crime. A seminar was also held at the Forum Secretariat from 19-20 June, that was attended by Tara Savou from the PIDC Secretariat, where by the Australian Federal Police presented an overview of the "West African Organised Crime".

The Secretariat is also preparing itself for the PIDC Annual Conference 2003 in Tonga from 10-12 September and we are looking forward to meeting all members thereWe look forward to working with you all through the remaining months of 2003. Tara Savou – PIDC Secretariat
